

TERMS AND CONDITIONS OF USE

Please read the following Terms of Use carefully before using any of the websites (each website a "Innersight Pictures Site" and collectively, the "Innersight Pictures Sites") operated by INNER SIGHT PICTURES LLC ("INNER SIGHT PICTURES"). Please note that we may, in our sole discretion, modify these Terms of Use without notice to you. Therefore, please continue to review these Terms of Use when using any of the Innersight Pictures Sites. By continuing to access and use any Innersight Pictures Site after the Terms of Use have been modified, you will be deemed to have agreed to such modifications.

1. Registration and Passwords

Registration is not required to browse the Innersight Pictures Sites.
